

RoHS-Declaration of Conformity (EC Directive 2011/65/EU)

We hereby confirm the conformity of our products in accordance with the RoHS Directive 2011/65 / EU (RoHS2) of the European Union on the restriction of the use of hazardous substances in electrical and electronic equipment as well as compliance with the permissible maximum concentration in homogeneous materials in weight percent of <0.01 % for cadmium and <0.1% for lead, mercury, hexavalent chromium, polybrominated biphenyl (PBB), polybrominated diphenyl ether (PBDE), bis(2-ethylhexyl) phthalat (DEHP), bytylbenzyl phthalat (BBP), dibutyl phthalat (DBP), di-isobutyl phthalat (DIBP) according to Annex II of the Directive.

We confirm that we use only RoHS-compliant components as well as RoHS-compliant manufacturing processes in our products.

REACH-Regulation (EC) No 1907/2006

Keller HCW GmbH's division ITS is a „downstream user“ as a manufacturer of electronic and electrical products with the meaning of the REACH-Regulation

No 1907/2006. Obligations arising from the production and placing on the market of substances / chemicals for pre-registration and registration (ECHA) are not applicable to us. Our products are commodities and therefore they cannot be defined as substances or preparations. Furthermore, no substances are released from our products under normal and foreseeable conditions of use. Therefore, KELLER HCW GmbH's division ITS is not subject to the registration requirement or the obligation to create safety data sheets.

For the products we have developed and placed on the market, we can confirm that the legal prohibitions on substances are adhered to. To the best of our knowledge, none of our products contain a substance of concern (SVHC) with a concentration of more than 0.1%, regarding the candidate list of the REACH Regulation. Our suppliers are obliged to comply with the prohibited substances list and the legal regulations.


